

**Pace, the Suburban Bus Division of the Regional  
Transportation Authority (“Pace”)  
Ventra on Paratransit Sweepstakes Rules**

**HOW TO ENTER:**

To be automatically entered in the Sweepstakes, you must:

- Be certified for ADA paratransit by the Regional Transportation Authority of northeastern Illinois (“RTA”);
- Possess an ADA paratransit Ventra card furnished by the RTA;
- Have online access to your Ventra card account (contact Ventra at (866) 669-8368 Monday through Friday from 6:00 a.m. to 8:00 p.m. and Saturday from 8:30 a.m. to 5:00 p.m. Central Time to set up online access); and
- Pay for the total cost of at least one ADA paratransit trip with your Ventra card account and complete that trip anytime between 12:01 a.m. Central Time on October 5, 2020 and 11:59 p.m. Central Time on January 1, 2021 (“Sweepstakes Period”).

**ALTERNATE METHOD OF ENTRY:**

You may also enter the Sweepstakes by sending a 3-1/2” x 5” postcard with your name, current mailing address, and email address or phone number by U.S. mail to: Ventra on Paratransit Sweepstakes c/o Pace, the Suburban Bus Division of the RTA, 550 W. Algonquin Road, Schaumburg, IL 60005 Attention: Marketing Manager. Postcard entries must be postmarked during the Sweepstakes Period to be included in the random selection of winners.

**PRIZE TERMS AND CONDITIONS:**

Five winners will each receive one Amazon Echo Plus (2nd generation) Smart Speaker (“Prize”), which has an estimated retail value of \$150. The Prize is not transferable, exchangeable, or redeemable for cash and is subject to availability. Pace reserves the right to offer an equivalent prize if the Prize is unavailable. The Prize is awarded “as is” with no guarantee or warranty, either express or implied, by Pace.

## **RULES AND ELIGIBILITY:**

No purchase is necessary to enter. A purchase will not improve chances of winning with an entry. Only legal residents of the United States who are 18 years of age and older may enter. Only a contestant who has complied with these Rules is eligible to win the Prize. All contestants have an equal chance of winning. Federal, state, and local laws and regulations apply. Void where prohibited by law. Pace reserves the right, at its sole discretion, to cancel, suspend, and/or modify the Sweepstakes at any time for any or no reason and to disqualify any entry.

Limit one entry per person.
