## Public Hearings on the Proposed 2023 Budget

Notice is hereby given that Pace, the Suburban Bus Division of the Regional Transportation Authority, is holding virtual and in-person public hearings on its proposed 2023 Operating and Capital Budget Programs, 2023-2025 Financial Plan for Operations, and 2023-2027 Capital Plan in accordance with the public hearings schedule below.
