Taxi Access Program (TAP) REMINDER

Pace's Taxi Access Program (TAP) fare in Chicago has been reinstated with new, lower \$2.00 fare

Still less expensive than ADA Paratransit!

You can load rides (\$2 each) to your TAP account, either online, by mail order, or in person. See **PaceBus.com/TAP** for a reminder of the instructions for loading rides to your account. That page now contains an updated order form reflecting the \$2 fare.

TAP riders should continue to swipe their TAP card at the end of their trip, as they always have. For each TAP ride taken (up to 8 per day), a ride valued at \$2 will be deducted from the account. Riders are still responsible for any taxi fare amount over \$30 and additional taxi surcharges.

If you had (before March 2020) purchased TAP rides, you may already have some rides available in your account. You can check your account balance online at PaceBus.com/tap, or by phone (call 1-877-722-3827, option 2, then option 2).

NOTE: For each ride you purchased for \$3 in 2020 or before, your account now has the equivalent dollar value with which you can buy \$2 rides. For instance, if you bought 8 rides for \$24 in 2020, you now have \$24 in value in your account, good for 12 rides in 2023.

Prioritizing accessibility and innovation

Recently the Pace Board approved an award for a seven-year contract to SCR Transportation, with over 30 years as a service provider in the region. SCR will begin to provide uninterrupted paratransit service in DuPage and Kane Counties on June 24, 2023. In addition to paratransit services Pace provides fixed route bus service, including the innovative Bus on Shoulder program, Pulse- bus rapid transit, and 10 On Demand services in the region. Pace also subsidizes Uber trips to provide non-traditional options to ADA Paratransit customers.

Pace Connect coming soon!

The Pace Board awarded an 18-month contract for Pace Connect, a new TNC rideshare program, to Via. Pace Connect uses accessible vehicles to pick riders up in two areas. One Pace Connect zone will serve workers commuting from the CTA Blue Line to cargo areas at the south end of O'Hare Airport. The other will serve an area surrounding Pace's Harvey Transportation Center bounded by 144th St., I-94, I-294, and I-57.

While both areas are already served by Pace fixed routes, these pilots offer first-/last-mile service and operate throughout nighttime and early morning hours when regular service is limited. The pilots will help Pace determine whether it is suitable, costeffective, and efficient to incorporate this service type into Pace's family of services. The contract includes six months for planning and a year of service. This project is in partnership with Cook County and RTA.

These new vehicles will help Pace expedite our transition to a zero-emission fleet while reducing pollution in the Elgin area.

Pace, through our Project Zero initiative, is committed to converting its entire fleet to a zero-emission fleet by 2040. This is an ambitious and significant investment which includes the upgrading of infrastructure at 11 bus garages.

Pace is incredibly grateful for the funding provided by Congressmen Casten and Brad Schneider, as well as the federal funding for other Pace improvements sponsored Congressman Bill Foster, Congressman Chuy Garcia, and former Congresswoman Marie Newman.

Award presented as Pace Board of Directors approves electric car charging infrastructure at nine locations

On April 19, Pace was honored with the Chicago Metropolitan Agency for Planning (CMAP) Regional Resilience Award for the agency's **Project Zero** initiative. CMAP Executive Director Erin Aleman presented the award to Pace at the agency's April 2023 Board of Directors meeting. Project Zero is Pace's commitment to operating a zero-emission fleet by 2040.

"Project Zero was a major step forward that we all took together," said Pace Executive Director Melinda Metzger. She also noted that "Pace's **North Division** in Waukegan will be the first garage to be converted to a fully electric fleet. This decision was based on environmental concerns and our ongoing work to create an innovative, equitable,



Electric Vehicles are Coming!

Project Zero is underway! Pace is in the process of buying equipment that will enable us to charge electric buses at North Division. In addition, thanks to a recent upgrade, our first electric bus can now be charged at our newest garage in Plainfield! This is the first permanent charging equipment to be wired into one of our Divisions.

Pace is also awarded a contract for a project that will add electric car charging stations (and related electrical system upgrades) at eight passenger facilities as well as our corporate headquarters. Construction is projected to start later this year and be completed by early 2024.

Project Zero began with the delivery of Pace's first electric bus in 2022 and the completion of the agency's **fleet transition plan.** Twenty more buses are scheduled for delivery later this year as Pace develops its facility transition plan and begins work on a network revitalization plan.
