




ReVision is an opportunity to rethink our network of services and build on the principles of accessibility, equity, and productivity defined in the *Driving Innovation* strategic vision plan.

Combining comprehensive technical analysis and ongoing conversations with communities about their transit priorities, the study will review and reimagine where and how often Pace routes should run, and what types of service are appropriate for the region.



## **FUNDING PROGRESS**

Pace continuously reviews where and how its funding is directed to maintain a transit network that is efficient and in a state of good repair, and to ensure riders and communities benefit the most from spending and allocations.




In Fiscal Year 2025, design and build projects at North Division (Phases 1 and 2) and Harvey Transportation Center will continue. New funding is expected to continue supporting River Division electrification efforts. The complete and final 2025 budget is expected to be approved in November 2024.

### **Expanded Funding: A Closer Look**

#### **Community Project Grants**

Five Community Project Funding federal grants, signed into law by President Biden in March and supported by multiple members of the northeastern Illinois Congressional delegation, assist the *Project Zero* initiative and Pulse program.



#### **Rebuild Illinois**

Rebuild Illinois capital funding totaling \$75.9 million was reprogrammed this past spring to support and expand *Project Zero* electrification efforts at River Division in Elgin.

#### Federal Transit Administration (FTA) Low or No Emission Grant Funding

The FTA grant in July of \$30.9 million, plus Pace's matching funds of \$5.46M, helps advance our *Project Zero* initiative to transition all fixed-route buses to zero emissions.

### A More Comfortable Wait

Mayor Alexander-Basta's support on the construction of a new building at one of our most successful services – the I-55 Bus-on-Shoulder – has been vital to the project's success.

When complete, the facility will include a waiting area and amenities that protect waiting riders from inclement weather, and will be fully accessible to riders of all abilities.

The improvements come in addition to recent upgrades that include additional parking spots and an electronic bus tracking sign.



# The Power of Partnerships

State Sen. Murphy joined a recent Pace event to celebrate how collaboration among transit agencies is reducing congestion and strengthening connections between communities on the Pulse Dempster Line through faster bus service, accessible trip information, and modern amenities.

Murphy notes the Pulse program provides reliable, safe, economical, environmentally friendly, and comfortable movement from suburb to suburb or to the airport. Such efficient and innovative service is the goal of our partnerships with other agencies and our investments in infrastructure.

The Dempster Line improvements join a number of options focused on this goal, including the reservation-based, self-service VanGo and Feeder Vanpool programs; Transit, an easy-to-use trip planning app; and rideshare programs like the DuPage Access Program.

### The Value of Access

A longtime Pace rider-advocate, CAB Member Powell helps us determine where advances in technology and engineering can improve service, whether it's to and from Chicago or between any of the many suburbs in our six-county region where people work, play, and live.

The groundbreaking of our newest ADA Paratransit transfer facility in Schaumburg demonstrates our ongoing commitment to ensuring all riders can access efficient public transit and state-of the-art facilities where they feel safe and comfortable between rides.



# **A Supported Workforce**

State Rep. Davis joined us at the July ribbon cutting for a new administrative facility in Markham, marking a significant milestone in modernizing Pace operations, bolstering our south suburban workforce, and enhancing central Safety and Training.

This latest investment, which includes the introduction of a bus operator training course, has spurred economic development through job creation and, by supporting Pace service in Markham, will improve access to employment for south suburban communities.

The \$40 million campus project was made possible by *Rebuild Illinois* and additional state funds, as well as the Federal Transit Administration, RTA, and Pace capital funds.
